Presentation, discussion and update for Case P-23-16-AM, a proposed text amendment of Zoning Ordinance Article 1-7: <u>Parking, Loading and Circulation Regulations</u> regarding requirements for guest parking, electric vehicle parking, accessible parking, motorcycle, and bicycle parking.

Planner Leftwich gave a presentation on case P-23-16-AM, proposed text amendments of Zoning Ordinance Article 1-7 and asked for questions and comments from the commission.

### Comments included:

- Required number of spaces.
- Requirements and costs of a Level II charger.
- Developer responsibility and EV charging stations.
- Minimal amount recommended.
- Demand issues and anticipating change.
- Opportunity to generate business by treating EV station like a vending machine.
- Trend that younger people aren't buying cars, including EV cars.
- Put conduits into rentals for the future.
- Encouraging the use of electric vehicles and incentives rather than mandates.
- How many charging stations the city currently has and their usage.
- Emerging technology and anticipating demand.
- Guest parking on the high end rather than low end.

Interim Planning Manager Urias stated we are providing a flexible minimum baseline in order to avoid being overly burdensome to the developer as they can ask for a PD amendment to the code, which we don't want either.

Director Esquivias stated incentives are probably not going to be development fees waivers.

Director Esquivias asked Chair Hantzsche if the commission would like another work session or have a public hearing. Chair Hantzsche responded that the commission would like another work session.
