FIRST AMENDMENT TO PRE-ANNEXATION DEVELOPMENT AND DRAINAGE SETTLEMENT AGREEMENT BETWEEN THE CITY OF APACHE JUNCTION AND FORTUNE TRAVEL, INC.

THIS AMENDMENT is made and entered into this ___ day of ____, 2025, ("the Execution Date") by and between the CITY OF APACHE JUNCTION, ARIZONA, an Arizona municipal corporation ("City"), and FORTUNE TRAVEL, INC., an Oregon corporation ("Developer"), sometimes collectively referred to as the "Parties" or individually as the "Party".

RECITALS

- A. On August 18, 2009, the Parties entered into a Pre-Annexation Development and Drainage Settlement Agreement (the "Agreement") for development of one hundred twenty-three (123) acres located adjacent to the southeast corner of Southern Avenue and Meridian Boulevard (the "Property").
- B. Since 2009, ADOT condemned and developed the SWC of the Property for a freeway on ramp and no other development has taken place. The Agreement set to expire on May 30, 2030 ("Expiration Date").
- C. Developer and City desire to amend the Agreement for an additional ten (10) years after Expiration Date.

AGREEMENT

NOW, THEREFORE, in consideration of mutual promises contained herein and other good and valuable consideration, the receipt and adequacy of which is hereby acknowledged, the Parties agree to amend the Agreement as follows:

A. Section 2. <u>TERM</u>. The original Term of this Agreement is from August 18, 2009 through May 30, 2030, or until all obligations have been fully performed, which ever date is sooner. The Term is extended with an end date of June 30, 2040, but there shall be no further extensions unless agreed to by an Amendment to this Agreement. All obligations of the City and Developer under the Agreement remain in full force and effect.

Additionally, except as expressly amended herein, all other terms and provisions of the Agreement shall remain in full force and effect.
