

**FIRST AMENDMENT TO PROFESSIONAL SERVICES AGREEMENT
BETWEEN THE CITY OF APACHE JUNCTION AND
SPEEDIE & ASSOCIATES, LLC**

THIS AMENDMENT is made and entered into this 17th day of June, 2025 (“the Execution Date”) by and between the CITY OF APACHE JUNCTION, ARIZONA, an Arizona municipal corporation (“City”), and SPEEDIE & ASSOCIATES, LLC, an Arizona limited liability company (“Consultant”), sometimes collectively referred to as the “Parties” or individually as the “Party”.

RECITALS

A. On August 15, 2022, the Parties entered into an Agreement for design/planning and general civil engineering services.

B. The Agreement expires on August 14, 2025 and the City desires to extend the term of the Agreement for one year pursuant to the terms of the Agreement.

AGREEMENT

NOW, THEREFORE, in consideration of mutual promises contained herein and other good and valuable consideration, the receipt and adequacy of which is hereby acknowledged, the Parties agree to amend the Agreement as follows:

A. The preamble is deleted in its entirety and replaced with the following:

“THIS AGREEMENT is made as of the 15th day of August, 2022 (the “Effective Date”) by and between CITY OF APACHE JUNCTION, an Arizona municipal corporation (“City”), and SPEEDIE & ASSOCIATES, LLC, an Arizona limited liability company (“Consultant”), both of which may be hereinafter referred to collectively as the “Parties,” for the project entitled “PW2022 – PUBLIC WORKS ON-CALL SERVICES” (the “Project”).

B. Section 4, titled “TERM/RENEWAL” is hereby amended as follows:

“The term of this Agreement shall commence on August 15, 2025 and end on June 30, 2026.”

Except as expressly amended herein, all other terms and provisions of the Agreement shall remain in full force and effect until the Agreement is terminated.
