E. District Director Report

3. [26-150](#) Presentation, discussion, and update on Arizona Department of Water Resources (ADWR) annual report.

District Direct Loggins presented an overview of the Arizona Department of Water Resources annual report. He summarized the District's annual water usage and while demand has increased due to new development, the Gallons per Capita per Day has decreased year after year. This decrease is due to conservation efforts by the District and the installation of Automated Metering Infrastructure. Lost and unaccounted water was less than the 10% required by state statute.

4. [26-151](#) Presentation, discussion, and update on Salt River Project-Central Arizona Project interconnection facility.

Mr. Loggins presented an update on the Salt River Project-Central Arizona Project Interconnection facility.

5. [26-152](#) Presentation, discussion, and update on District wide water system.

Mr. Loggins presented an update on Well 10 in the Blossom Rock subdivision. Test pumping will begin this month.

Mr. Loggins presented an update on the expansion of the Superstition Area Water Plant. Production rate will go from 4 million gallons per day (MGD) to 10 MGD. Construction started January 1, 2026, and is expected to be completed July 1, 2028.

Chairperson Soller expressed his gratitude for the work the District has done with keeping rates reasonable. He also asked for an update on the pure water demonstration trailer. Mr. Loggins

explained that he is working on getting vendors since this is a specialized project.
