Organization Information

Provide background information on your agency to include services currently being provided.

The Apache Junction Community Development Corporation (AJCDC) was established in November 2002 as a 501(c)3. Our purpose is to support and improve the health and quality of life of individuals and the community by combatting community deterioration through redevelopment; and working in neighborhoods to help those less fortunate maintain their yards. AJCDC is committed to helping our community by focusing on initiatives that bring about positive change and create strong neighborhoods. Through community outreach and partnerships within Apache Junction, including Pinal County islands, AJCDC works to create a neighborhood-friendly atmosphere, helping local businesses to thrive. AJCDC has been in operation for over 20 years, since Nov. 2002.

AJ CDC is requesting \$6,500 for fiscal year 2024-2025 to cover minimal administrative costs and project costs, including tools, dumpsters and associated fees.

Mission:

Working together to maintain and create safe affordable housing, support economic opportunities, instill a sense of community pride and commitment, and enhance the physical image of Apache Junction.

Vision:

Through community involvement, having a common and unified purpose to **"Make a Difference"** while providing conduits and assistance that enable a strong and sustainable community.

Services provided:

Neighborhood Cleanup Project: Focusing on the neediest areas of the community, this project helps residents in need (over 65 or disabled) to dispose of excess or improperly dumped trash and refuse. The Neighborhood Cleanup Project, begun in 2015, has cleaned up many properties in Apache Junction, disposing of over 100 tons of trash and refuse. Requests for assistance are considered based upon the resident's need and available AJCDC funding.

Make a Difference Day: Begun in 2019, AJCDC Make a Difference Day builds on the success of the Neighborhood Cleanup, with a communitywide focus. Each year, trails are improved and new plants are planted at Silly Mountain and Flatiron Parks; tons of trash and refuse are removed from public areas (38 tons to date), and the city's focal point is cleaned and renewed. partners with city businesses to make this event a success, receiving donations of tools, gloves, shirts, plants, and water. Volunteer numbers have grown every year; the 2022 total was 117 volunteers. The success of Make a Difference Day led the AJCDC to join forces with the City of Apache Junction and Just Serve, to assist residents needing help all year.

Focal Point Enhancement Project: The Apache Junction Focal Point is an identifiable landmark that enhances the downtown area, reflecting the City's beautiful surroundings and pioneer history. Residents and visitors may purchase a brick to engrave to honor the person or event of their choice; AJCDC helps to maintain the Focal Point area through regular cleanups and care of the installed bricks. CDC also continues to support the Mural Project at Flatiron Park.

Apache Junction Community Development Corporation (CDC) serves only those citizens living in their own home within the city limits, including county islands within the city limits. Clients must also be disabled (14.6%), veterans (13.8%), elderly (34%), or living below the poverty line (12.2%).

EXAMPLE projects from 2022-2023

- **Disabled ramp:**
The CDC took on a property cleanup project on 20th Ave that was a code compliance case. The property was also included in the 2022 Make A Difference Day as a project. The property owner is a disabled veteran who has to use a wheel chair most of the time. The wheel chair ramp at his front door had been severely damaged when a saguaro cactus in his yard fell on it. The owner had no ability to fix the ramp. The CDC contacted a group out of Mesa, but they were unable to help. The CDC put out a message on Nextdoor on the internet and a person from Gold Canyon responded. The CDC purchased the materials need and the person donated the labor time.
- **Property cleanups:**
The CDC took on multiple property cleanup projects, from the CDC organizing volunteer labor to the CDC paying for a roll-off dumpster and the property owner cleaning their own property. All are code compliance cases.

Problem Statement

What is the nature and extent of the problem to which you are trying to address?

AJ CDC was formed to combat deterioration within the community, mainly through cleanup and rehabilitation of blighted properties and structures. There are currently 233 Code Compliance cases within the Apache Junction city limits and there is no reason to expect the need to be lessened in the near future. Many of these cases are caused by inability of the owner / resident to properly care for the property due to age, disability, or lack of funds to hire assistance. This may allow trash and debris to accumulate, weeds to proliferate, and structures to be neglected, resulting in code compliance issues, increased fire risk, and other health concerns.

To whom is this happening?

Ownership of distressed property is not limited to any one socioeconomic group; however, the Apache Junction CDC limits its assistance to those owner / residents who are unable to help themselves due to age, infirmity, disability, illness, or poverty.

Why is this happening? What are the reasons or causes for the problem?

Decline of structures may be caused by financial inability to pay for repairs. Accumulated trash and debris on properties may be due to several factors, including insufficient space under roof on the property; hoarding or other mental illness disorder; physical inability to remove and discard debris and refuse; financial difficulties or other life events.

AJ CDC partners with the Apache Junction Code Compliance department, which averages 50 cases per code enforcement officer at any given time. This is an evident and ongoing problem.

What will happen if the problem is not addressed?

If properties are not cleaned up and removed from Code Compliance status, the owner may be fined and/or a lien placed on their property, up to and including condemnation of the property; the City may then become responsible to remedy and clean the property; rodents and other vermin may be attracted to the property in the meantime; the property may present a fire hazard until such time as it is cleaned up. Properties will continue to deteriorate until such time as they are cleaned up.

What are the gaps between what exists and the solution?

Gaps include availability of volunteers, resources and funding.

Decline of structures may be caused by financial inability to pay for repairs; accumulated trash and debris on properties may be due to several factors, including insufficient space under roof on the property; hoarding or other mental illness disorder; physical inability to remove and discard debris and refuse; financial difficulties or other life events.

AJ CDC endeavors to bridge those gaps through property cleanups, weeding, and trash haul-off. These activities incur costs, which AJ CDC covers with grant funding.

Local documentation of this problem includes Development Services as well as AJ CDC documentation of completed projects (recaps and photographs of "Before" and "After" of cleanup sites).

AJ CDC partners with the Apache Junction Code Compliance department, which averages 50 cases per code enforcement officer at any given time. This is an evident and ongoing problem.

Has the city or the commission identified this as a problem?

Yes. The Apache Junction Development Services Dept. identifies properties as needing cleanup and remediation. There are currently 233 open Code Compliance cases assigned to 5 Code Officers and one Manager, averaging 47 open cases per Officer.

Project Proposal

What is the proposed project to address the problem identified above? Please address the who, what, when, where, why, and how.

WHO: Apache Junction CDC proposes to identify (with the AJ Code Compliance Department's assistance) properties needing remediation.

WHAT: Properties within the Apache Junction city limits that have excessive trash, weeds, debris, etc., and that therefore attract rats and other vermin to the neighborhood (Community Revitalization projects); provide Household Hazardous Waste Transport Assistance for citizens who cannot bring items to the City drop-off location; Make a Difference Day, with multiple cleanup and revitalization projects throughout the City.

WHEN: These properties may be identified at any time; weeds tend to be at their worst in the late spring but trash and debris accumulate at any and all times throughout the year.

WHERE: Properties within the Apache Junction city limits, including county islands; public spaces such as the Focal Point, city parks such as Flatiron and Silly Mountain.

WHY: Excessive trash, weeds, debris, etc. attract rats and other vermin, devalue neighboring properties and could eventually cause a fire hazard. Cleaning up these properties removes these hazards.

HOW: AJ CDC proposes to send Board members and volunteers to the identified sites, remove the weeds with landscaping equipment, remove debris with labor to a trailer. Weeds and debris will then be taken to the local landfill for disposal.

Make a Difference Day is an event that recurs annually, taking several months to plan, and to enlist volunteers and resources. It is a one-day event with citywide participation.

Why is this a need to be addressed?

Apache Junction has relatively high populations of elderly and disabled persons. (Statistics as of 2021 State of AZ)

Elderly, Age 55-74: 12,242 (32% of population)

Elderly, Age 75+: 6,425 (16.8% of population)

Disabled: 3,449 (8.3% of population)

There are no statistics for winter visitors with property in AJ that also are a code compliance problem)

Below Poverty Line: 12.2% of population

Many times, these are people living independently in their own homes, but they are not able to maintain proper cleanliness and state of good repair on their property. If they fall under code compliance issues, they face fines as well as potential liens and the condemnation and loss of their property.

Who will you serve with this project?

AJ CDC serves:

- The individual property owner / resident, who is able to stay in the home.
- The neighbors, who no longer have a trash / refuse pile with associated rats, vermin and fire hazards right next door.
- The City of Apache Junction, which no longer has to take action (and assume the concomitant costs and liabilities for those actions) to clean up noncompliant properties.
