## FIRST AMENDMENT TO AGREEMENT FOR BULK FUEL BETWEEN THE CITY OF APACHE JUNCTION AND SENERGY PETROLEUM, LLC

THIS AMENDMENT is made and entered into this <a href="#periodecolor: 19">19</a> day of <a href="#periodecolor: 19">Apriodecolor: 19</a> ("the Execution Date") by and between the CITY OF APACHE JUNCTION, ARIZONA, an Arizona municipal corporation ("City"), and SENERGY PETROLEUM, LLC, an Idaho limited liability company ("Contractor"), sometimes collectively referred to as the "Parties" or individually as the "Party".

## RECITALS

- A. On August 20, 2024, the Parties entered into an Agreement for the purchase of bulk fuel (the "Agreement") under which City purchased bulk fuel from Contractor utilizing the State Cooperative Contract No. CTR063147.
- B. The Agreement expires on June 30, 2025 and the City desires to extend the term of the Agreement for one year pursuant to the terms of the Agreement.

## **AGREEMENT**

NOW, THEREFORE, in consideration of mutual promises contained herein and other good and valuable consideration, the receipt and adequacy of which is hereby acknowledged, the Parties agree to amend the Agreement as follows:

A. The preamble is deleted in its entirety and replaced with the following:

"THIS AGREEMENT ("Agreement") is made and entered into by and between the CITY OF APACHE JUNCTION, an Arizona municipal corporation ("Licensor" or "City") and SENERGY PETROLEUM, LLC, an Idaho limited liability company ("Contractor"), who shall be collectively referred to as the "Parties" or individually as the "Party, for the project entitled "bulk fuel.""

B. Section 5, titled "Contract Term" is hereby amended as follows:

"The term of this Agreement shall commence on July 1, 2025 and end on June 30, 2026."

Except as expressly amended herein, all other terms and provisions of the Agreement shall remain in full force and effect until the Agreement is terminated.
