Horizon Health and Wellness is a non-profit 501(c)(3) integrated health care agency licensed by the State of Arizona to provide an extensive array of inpatient, outpatient, crisis services, and residential services, including primary care, behavioral health, and preventative healthcare services in central and southern Arizona. Our mission is: *Provide integrated healthcare that addresses the whole person and promotes wellness using best practices to enhance the quality of life of the individuals, families and communities we serve.* Horizon Health and Wellness has offered healthcare services to central and southern Arizona for over 40 years. Horizon's origins began in the late 1970's as the Behavioral Health Agency of Central Arizona. Horizon adopted the name Horizon Human Services in 2000. In 2015 Horizon Human Services merged with Mountain Health and Wellness to become Horizon Health and Wellness, as we are known today. Horizon also values giving back to the communities we serve and partners with local government, other stakeholders, and partners to give back to the communities we serve in many other ways.

Salvation Army - Sargent Darla Malone

We have partnered with the Salvation Army for the past 3 years on a project called Horizon Helps where we provide food boxes for our clients in need out of our Apache Junction practice. Clients can help themselves to food that is brought in by the Salvation Army and placed in our lobby area. We also worked with the Salvation Army when we had a food pantry here on site as well. We have collaborated on Project Shower and AJ Cares when Covid-19 was in full swing as well to deliver groceries to the elderly in Apache Junction so they did not have to go out into grocery stores.

City of AJ Parks and Recreation Jamie Sullivan and Team

We do many collaborative partnerships and activities with the Parks and Recreation Department here in Apache Junction. Our largest collaborative project is co-hosting the annual Earth Day Festival here in EHP, where last year we saw a record breaking 4,000 people in attendance. This is on the calendar this year for Saturday, April 1, 2023 and we are expecting the same or more of a turn out.

We also coordinate many other activities out in EHP for Parks and Recreation that are both educational and child-age activity based. Parks and Rec have full use of our park whenever they have a special event that they would like to host there, such as rock painting parties that benefit the residents of Apache Junction.

We have also coordinated with the Parks and Recreation Department on Mental Health First Aid Trainings to their staff and other residents in Apache Junction, we provide subject matter experts that present at their health fair.

Genesis Project - Trinity Cole

We work with Genesis and have been co-located in their buildings to provide social services to the clients that partake in their programs.

Apache Junction Chamber of Commerce

Horizon has been chamber ambassadors and has volunteered to help with many of the Chamber's events throughout the past years. Horizon was also selected as the recipient of the Best Large Organization award for 2022 from the Chamber.

Central Arizona College

Horizon has partnered with Central Arizona College in providing Mental Health First Aid to students in their nursing program. We have also been available to deliver other mental and physical health education seminars upon request.

Problem Statement

What is the nature and extent of the problem to which you are trying to address?

Earth Heart Park (EHP) is the legacy left behind and designed by former CEO of Mountain Health and Wellness, Rob Evans. The park is open to the community and utilized by many of the residents of Apache Junction. It is also a great venue for community events and festivals that Horizon offers the community free of charge annually. The park, and what it brings to the community magnifies Horizon Health and Wellness's (HHW) Vision to "alleviate human suffering by empowering people to attain their optimum potential" and our missions to "provide integrated health care that addresses the whole person and promotes wellness using best practices to enhance the quality of life of the individuals, families, and communities we serve".

Many residents make use of Horizon's EHP for a variety of occasions including, but not limited to: family picnics, community classes, gardening volunteer hours, relaxation, exercise, a walk with their pets, socializing, classes and events through City of AJ Parks and Recreation, and organizational fundraising events. There is never a fee to use the facilities in EHP and is open on a first come, first serve basis. Horizon also makes use of the park for many different events and client activities.

Horizon has recently made many great additions to the park for the enjoyment of the residents in Apache Junction including exercise equipment, a butterfly friendly area, expansion of our community garden, a meditation fountain, and additional plants and trees. HHW has even larger plans for the park this year.

EHP currently has a community garden where residents can cultivate and harvest plants that are maintained as part of a partnership between the community and HHW. The park, at times, provides a meal for the homeless, a therapeutic respite for others, a place where children gather for art workshops, and a fun place to hold family-oriented events. In 2021 and 2022, this group has given away 775 pounds of free produce that was mainly given out to low income residents of Apache Junction. Horizon has hired a Master Gardener to transform the community gardens into a Master Garden destination and teaching garden for all ages. We currently have 6 Master Gardeners and have had 41 community volunteers working in EHP's garden and logging in 1,670 hours over the past two years. The volunteer program is a place members of the community can be a part of transforming the community garden. Many of these volunteers during the summer enjoy working in the garden after dark as the day starts to cool off.

Lighting in the park has always been an issue for people wanting to host events during the late afternoon and evening hours. There is also a safety factor involved with not having adequate lighting in our park. This grant, if approved, would allow Horizon to purchase adequate lighting for the park so that the park can be used by the community more often and for evening activities that we are getting requests for. More families will feel safer to come and enjoy everything that the park has to offer with the lighting that we are requesting. One garden volunteer states, "Gardening helps my PTSD by giving me a place to relax the mind around nature, friends, and community. It allows me to learn about others around use and how important human kindness is. Earth Heart has giving me a

To whom is this happening?

All residents of Apache Junction are allowed to use the park and all of the amenities. The lighting will make the park more accessible for longer periods of time for all residents. We have residents utilizing the amenities in EHP throughout every day and this would expand the use of the park and facilities for many more hours per day.

Why is this happening? What are the reasons or causes for the problem?

There is not adequate lighting for events once the sun sets and prior to the sun rising in the morning when more people would want to access the park and it's amenities especially in the summer months when the temperatures are milder at those times. Horizon has had some incidences in EHP where safety was of concern and we feel that putting up adequate lighting will make the park a much safer place to enjoy in the darker hours so more people will feel comfortable using the park. There are many community groups that would like to utilize the park for events and structured activities after dark, but find they can't due to not having adequate lighting.

How do you know this is a problem? Provide statistics that support your claim. If available, please use statistics collected from your agency data and/or local documentation.

Use of Horizon's EHP is not regulated nor tracked at this time due to being an open community park with no need for applications or cost to using the amenities. We have seen an increase in people being in the park with the new additions discussed earlier, but have no way to quantify them. We have had an increase in the need for police presence in the park in the past two years and have asked the city for this support to make our park a safer place to gather. They have increased driving by the park during the evening hours.

What will happen if the problem is not addressed?

If the lighting is not installed in EHP, the hours that the park can be safely accessed and utilized will continue to be limited to daylight hours only for both visibility and safety reasons. We will have to continue to turn away organizations, events, and activities in hours where lighting is not sufficient. We desire to make the park a place where families can come whenever they want and feel safe and comfortable while they are there.

What are the gaps between what exists and the solution?

The gap is having the funding to both purchase and install this new lighting for EHP. There are so many hours of daylight in a day and installing adequate lighting in the park would extend the ability for residents to use the park and all of its free amenities.

Is there local documentation which identifies this as a problem?

The 2018 Pinal County Community Health Needs Assessment indicated that Pinal County has 3 areas of focus that need improvement: physical activity, substance abuse, and mental health. In this same assessment, it was reported that 54% of community members were obese or overweight. It has been proven that community engagement in adult & youth physical activity has positive results. Apache Junction (AJ) has a current poverty rate of nearly 14%. Creating a more accessible, free resource that all community members can access will have a positive impact on resident's physical health and mental health, making for a healthier community. With the ever-increasing population in Apache Junction, more recreational activities are needed. Currently, there are few parks in AJ and no other park in the city that has exercise stations and expanding the hours that the park could be accessible due to added lighting would increase availability of the free resource.

There have also been police reports made that are housed with the City of Apache Junction regarding the safety issues discussed throughout this grant proposal.

Has the city or the commission identified this as a problem?

Not that this writer is aware of. City of Apache Junction first responders are aware of this security and safety issues.

Project Proposal

What is the proposed project to address the problem identified above? Please address the who, what, when, where, why, and how.

Horizon is proposing to purchase and have installed 12 solar powered lights throughout our stage (grass) areas in EHP (\$4000 quote installed). Horizon will also order and install an additional 3 lights in our pavilions area with a total cost of \$2,660. These additional 3 light posts will be shipped to Horizon and installed by our maintenance staff. We are also proposing to increase the lighting even further in our garden area with higher voltage string lighting that will illuminate that area for our garden volunteers so they can work in cooler temperatures in the summer hours. We are asking for an additional \$400 for this additional garden area lighting that our maintenance team will install. The total ask for this grant proposal is \$7,060. This additional lighting in EHP will expand the hours in which residents can use the amenities.

Is this a best practice or has it been proven successful in other places?

We have chosen to use solar powered lighting, which supports Horizon's vision to keep EHP an Earth-friendly environment.

Is this a new or continuing project?

The addition of lighting will be a new project however, we will continue to enhance EHP going forward as well.

Why is this a need to be addressed?

Lighting in the park has always been an issue for people wanting to host events during the late afternoon and evening hours. There is also a safety factor involved with not having adequate lighting in our park. This grant, if approved, would allow Horizon to purchase adequate lighting for the park so that the park can be used by the community more often and for evening activities that we are getting requests for. 
