Zach Sakas, Esq. of Greenberg Traurig, outside counsel for the Superstition Vistas Community Facilities District No. 2 presented to the Board a proposed amendment to the Community Facilities District (CFD) development agreement. He reviewed the purpose and history of the agreement and outlined three requested changes from the developer:

- Increase the general obligation debt service tax from \$3.85 to \$5.00.
- Increase the maximum assessment per lot from \$5,000.00 to \$12,500.00.
- Brookfield has requested that the 10 year period to submit projects be extended to 15 years.

Zach explained this is a common request because of county changes all over the state, referencing proposition 117.

Boardmember Cross asked regarding both CFD's how this affects commercial property. Brookfield representative Eric Tune, 14648 North Scottsdale Road, explained there is not commercial property connected to the district.
