Good afternoon, Mayor Wilson and Bryant,

Thank you for sharing your resident's concerns regarding electric service in the downtown area near the proposed apartment community, as well as the reports of "brownouts" from residents at the Lost Dutchman RV Park.

I've shared this information with SRP's Distribution Planning team. Based on their initial review, if the proposed apartment complex is comparable in size to others that have been built in the area, SRP has sufficient capacity to serve a development of this scale. A more detailed analysis will be conducted once formal plans and a service request are submitted, and we'll be able to provide additional information following that study. Currently, no issues are anticipated in serving a reasonably sized apartment complex at that location.

As for the brownouts, these are likely instances of low voltage. Our Distribution team reviewed SRP's voltage dashboard and found no indication of low voltage being delivered to this RV park. It's worth noting that mobile home and RV parks can present unique reliability challenges, as SRP provides power to a master meter, and the site owner is responsible for distributing electricity to individual units. In some cases, power quality issues – such as dimming lights – can result from the condition or capacity of the owner's internal distribution equipment.
