Planner Hernandez thanked all attendees for participating in the special meeting and noted for those viewing online that the purpose of the meeting was to review submissions for the Apache Junction High School traffic cabinet art competition. She stated that the winning design will be installed on the traffic cabinet located in front of the Circle K at Southern Avenue and Ironwood Drive. The winner will be notified by May 21, and painting is scheduled to begin on May 24.

Planner Hernandez began her presentation by reviewing the competition details, including awards and prizes for the winner and the terms of entry. She reported that a total of five designs were submitted. The Public Art Commission is responsible for selecting a preferred design to recommend to the City Council, and all entries will be presented for Council review.

She then presented the five submitted designs for commission discussion. During the review, Chair Danford inquired whether any design modifications could be made. Director Esquivias responded that the project must adhere to a defined timeline, limiting the opportunity for changes.

The commission discussed each of the five submissions and reviewed the rankings provided by the Youth Advisory Committee. Following this review, the commission reached a consensus to recommend Submission #2 by Sheyla Sebastian as their top choice for City Council consideration.
