RESOLUTION NO. 26-37

A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF APACHE JUNCTION, PINAL AND MARICOPA COUNTIES, ARIZONA, DECLARING AND ADOPTING THE RESULTS OF THE PRIMARY ELECTION HELD ON JULY 21, 2026.

WHEREAS, the City of Apache Junction, which is located in Pinal and Maricopa Counties, Arizona, did hold a primary election on the 21st day of July 2026, for voter selection of a mayor and three councilmembers; and

WHEREAS, A.R.S. § 16-642 requires a city that held an election to meet and canvass the election results not less than six days nor more than twenty days following the election; and

WHEREAS, the election returns have been certified by both counties and are now available for the canvass.

NOW, THEREFORE, BE IT RESOLVED by the mayor and council of the City of Apache Junction, Pinal and Maricopa Counties, Arizona, as follows:

SECTION 1. That the total number of ballots cast at said primary election, as shown by the attached reports from Pinal and Maricopa Counties, marked as Exhibit A was 6290.

SECTION 2. That the total number of ballots rejected, at said primary election, was 389.

SECTION 3. That the votes cast for the candidates for mayor were as follows:
