Our mission is: Provide integrated healthcare that addresses the whole person and promotes wellness using best practices to enhance the quality of life of the individuals, families and communities we serve. Horizon Health and Wellness has offered healthcare services to central and southern Arizona for over 40 years. Horizon's origins began in the late 1970's as the Behavioral Health Agency of Central Arizona. Horizon adopted the name Horizon Human Services in 2000. In 2015 Horizon Human Services merged with Mountain Health and Wellness to become Horizon Health and Wellness, as we are known today. Horizon also values giving back to the communities we serve and partners to give back to the communities we serve in many ways.

Horizon has received City of Apache Junction Health and Human Services funding in the past to operate this project which we are now asking for additional funding due to its success. Horizon Helps was a vision that was created during the COVID 19 pandemic - getting food to the people of Apache Junction that needed it. Horizon Helps in partnership with the Salvation Army provides food boxes to the individuals served at the Apache Junction clinic that are in need, the project is operated out of the lobby of the clinic, this project also includes a food pantry that is in the clinic where clients can come and get the food that they need. In addition, Horizon collaborated with Project Shower and AJ Cares during the pandemic to get groceries delivered to the elderly in Apache Junction, so this vulnerable population did not need to go to the grocery stores.

Horizon currently partners with several community agencies to provide an array of services, once such partnership is with CAHRA - Horizon operates a homeless street outreach team that finds homeless community members living in parks, streets, vacant lots etc and works with them to get their basic needs met. The street outreach team often utilizes the hotel voucher funding from CAHRA to get the individuals off the street and in a safe place that ensures the housing support staff can work with them to find permanent housing, get enrolled in mainstream benefits and provide referrals for healthcare when and if needed.

Another partnership that Horizon utilizes is with the City of Apache Junction Parks and Recreation Department. Our largest collaborative project is co-hosting the annual Earth Day Festival in Earth Heart Park where we commonly have over 4000 attendees. In addition, we have coordinated with the Parks and Rec department to provide their staff with Mental Health First Aid trainings.

Horizon has also partnered with the Apache Junction Chamber of Commerce often having staff volunteer at many of the Chamber's events throughout the year.

Problem Statement

What is the nature and extent of the problem to which you are trying to address?

Apache Junction has a population of approximately 43,431 per the World Population Review, with an average household income of \$64,653 and a poverty rate of 12.73%. University of Arizona data show that Pinal County has a food insecurity rate of 13.9% with 1 in 6 adults and 1 in 4 children affected. This is attributed to two factors one of which is the poverty rate and the other is the limited selection of grocery stores and distance to the stores with minimal public transportation options. The data also show that many individuals in the community do not get the recommended intake of fruits and vegetables which cause nutrient deficiencies often exacerbating chronic disease. In children, food insecurity and lack of nutrition affect development, academic performance and increase mental health issues such as anxiety, depression and hyperactivity.

Horizon currently operates a food pantry for the community members that come into our Apache Junction clinic to receive services. Many of these members have financial hardships that limit the amount and type of food that they can purchase. The food pantry that Horizon operates provides fresh vegetables, fruit and many other healthy items that are often very costly to purchase. The pantry is a huge success and it has outgrown the small refrigerator that we have as well as the area that is set aside for the food. We are in need of a larger refrigerator and shelving to store the food to ensure that we can continue to offer a variety of food and to assist us with keeping it as fresh as possible for as long as possible.

To whom is this happening?

Food Insecurity is affecting 13.9% of the population of Apache Junction. Many of these individuals and families come to the Horizon outpatient clinic in Apache Junction to receive their healthcare. Most of these individuals and families are low income living in subsidized housing, living paycheck to paycheck and not able to afford the fresh fruits and vegetables and healthy options at the grocery store. Food insecurity is a rising issue with the higher cost of food, housing, utilities and other basic needs.

Food insecurity for quite a few members of the community is happening due to various issues - higher housing costs, transportation costs/barriers in a rural population, higher costs of most goods/services with wage increases falling behind are just a few of the reasons for the increasing amount of individuals and families dealing with food insecurity.

How do you know this is a problem? Provide statistics that support your claim. If available, please use statistics collected from your agency data and/or local documentation

University of Arizona reports Pinal County to have a 13.9% rate of food insecurity - given the population of 43,341 this equals 603 people that are not getting enough food and nutrients. To address this Horizon is currently providing approximately 265 pounds of produce to the community members of Apache Junction which show the ongoing need of this pantry.

What will happen if the problem is not addressed?

If Horizon is unable to continue providing fresh produce to these community members, they will not have the means to obtain the food. This could cause more health issues in both individuals and children. Children will continue to suffer the consequences of poor nutrition which lead to poor academic performance and higher mental health issues. Adults will also suffer from the lack of nutrition which can lead to additional health issues.

What are the gaps between what exists and the solution?

The gaps that cause food insecurity are the lack of financial resources, lack of transportation and distance to grocery stores for many of the community members. The gap between what exists and the solution is the financial means to expand the storage capability in the Horizon clinic lobby to store additional fresh fruit and vegetables that can be grown in the garden. Members of the community that are experiencing food insecurity are already coming into the Horizon clinic and can obtain fresh food while there – solving both the transportation issue as well as providing fresh food rich in nutrients.

Horizon is proposing to provide additional food resources including fresh fruit and vegetables grown in the garden in Earth Heart Park to the residents of Apache Junction, specifically the Horizon clients that can come into the lobby of the outpatient clinic and retrieve whatever items they need or want. The lobby is open on Monday - Thursday from 8am to 7pm and Friday from 8am to 5pm the food is available during these hours.

Is this a best practice or has it been proven successful in other places?

Horizon has distributed over 265 pounds of produce during the last year at no cost to the residents of Apache Junction. This shows the program is successful and needed in the community.

Is this a new or continuing project?

This is a continuing project that we are hoping to expand so we can provide additional food to the community.

Why is this a need to be addressed?

Food Insecurity specifically the cost of healthy alternatives to processed and boxed food is a need of the general population but specifically to the low income people who also have health issues. Providing healthy food at no cost to this population will not only give them food to eat but will assist them in maintaining their health and increasing their health outcomes which lead to less cost overall to the health system and to the individuals.

Food insecurity for quite a few members of the community is happening due to various issues - higher housing costs, transportation costs/barriers in a rural population, higher costs of most goods/services with wage increases falling behind are just a few of the reasons for the increasing amount of individuals and families dealing with food insecurity.

How do you know this is a problem? Provide statistics that support your claim. If available, please use statistics collected from your agency data and/or local documentation

University of Arizona reports Pinal County to have a 13.9% rate of food insecurity - given the population of 43,341 this equals 603 people that are not getting enough food and nutrients. To address this Horizon is currently providing approximately 265 pounds of produce to the community members of Apache Junction which show the ongoing need of this pantry.

What will happen if the problem is not addressed?

If Horizon is unable to continue providing fresh produce to these community members, they will not have the means to obtain the food. This could cause more health issues in both individuals and children. Children will continue to suffer the consequences of poor nutrition which lead to poor academic performance and higher mental health issues. Adults will also suffer from the lack of nutrition which can lead to additional health issues.

What are the gaps between what exists and the solution?

The gaps that cause food insecurity are the lack of financial resources, lack of transportation and distance to grocery stores for many of the community members. The gap between what exists and the solution is the financial means to expand the storage capability in the Horizon clinic lobby to store additional fresh fruit and vegetables that can be grown in the garden. Members of the community that are experiencing food insecurity are already coming into the Horizon clinic and can obtain fresh food while there – solving both the transportation issue as well as providing fresh food rich in nutrients.

The lobby is open on Monday - Thursday from 8am to 7pm and Friday from 8am to 5pm the food is available during these hours.

Horizon has distributed over 265 pounds of produce during the last year at no cost to the residents of Apache Junction. This shows the program is successful and needed in the community.

Is this a new or continuing project?

This is a continuing project that we are hoping to expand so we can provide additional food to the community.

Why is this a need to be addressed?

Food Insecurity specifically the cost of healthy alternatives to processed and boxed food is a need of the general population but specifically to the low income people who also have health issues. Providing healthy food at no cost to this population will not only give them food to eat but will assist them in maintaining their health and increasing their health outcomes which lead to less cost overall to the health system and to the individuals.
