A RESOLUTION OF THE DISTRICT BOARD OF SUPERSTITION VISTAS COMMUNITY FACILITIES DISTRICT NO. 2 ADOPTING THE DISTRICT BUDGET FOR FY 2024/25 AND LEVYING A TAX.

WHEREAS, pursuant to Arizona Revised Statutes ("A.R.S.") § 48-716, the Treasurer of Superstition Vistas Community Facilities District No. 2 (the "District") prepared and submitted to the Board of Directors of the District (the "District Board") for approval a proposed District budget for fiscal year ("FY") 2024/25 (the "Proposed Budget"); and

WHEREAS, a public hearing was held on the date hereof.

NOW, THEREFORE, BE IT RESOLVED BY THE DISTRICT BOARD OF SUPERSTITION VISTAS COMMUNITY FACILITIES DISTRICT NO. 2, AS FOLLOWS:

SECTION 1 Adoption of Proposed Budget

The Proposed Budget in the form attached hereto as $Exhibit\ B$ is hereby approved and adopted as the final District budget for FY 2024/25.

SECTION 2 Tax Levy

A tax levy (the "Tax Levy") in the form attached hereto as Exhibit C is hereby ordered, approved and adopted, and the District Clerk is hereby directed to deliver certified copies of the Tax Levy to the Pinal County (Arizona) Board of Supervisors, to the Arizona Department of Revenue, and to any entity acting as trustee for any District bonds.

TAX LEVY

PURSUANT TO RESOLUTION No. 2024-006 SVCFD No. 2 passed on June 18, 2024 by the Board of Directors of Superstition Vistas Community Facilities District No. 2 (the "District"), it is hereby ordered levying an ad valorem tax on the net assessed limited property value of all taxable property within the District for FY 2024/25, such tax levy to be apportioned as follows: (i) at a rate equal to \$0.30 per \$100.00 of net assessed limited property value for the purpose of operation and maintenance expenses of the District; provided, however, that such rate shall not exceed \$0.30 per \$100.00 of net assessed limited property value, and (ii) at a rate equal to \$3.85 per \$100.00 of net assessed limited property value for the purpose of paying the principal of and interest on general obligation bond indebtedness to be incurred during FY 2024/25.
