Organization Information

Provide background information on your agency to include services currently being provided.

The Superstition Community Food Bank (SCFB) is a non-profit organization 501(c)(3) alding individuals, families, seniors, and children facing food insecurity since 1983. Food on demand is provided to people struggling with hunger in Apache Junction, Gold Canyon, Queen Creek, Northwest Pinal County, and East Mesa. We are the largest agency food bank for United Food Bank (UFB) in the East Valley. We distribute over two million pounds of food through our warehouse annually (the equivalent of over 1.5M meals) and help feed 42,000 people a year (over 15,000 eligible families). We follow the guidelines set forth by the Arizona Department of Economic Security (DES) and United Food Bank (UFB). Our food rescue program collaboration with UFB allows us to work with 14 large local grocers on a weekly basis.

SCFB continues to offer Commodity Supplemental Food Program (CSFP) through United Food Bank. The program provides supplementary United States Department of Agriculture food packages to the low-income elderly of at least 60 years of age. It is one of the fifteen federally funded nutrition assistance programs of the Food and Nutrition Service, a USDA agency. The CSFP currently serves about 600,000 lowincome people every month. Our CSFP program is held on the third Thursday of each month from 7:00 a.m. to 11:00 a.m. at the Food Bank and provides area seniors with an extra monthly food distribution exclusively for them. To be eligible for CSFP, a person must reside in Arizona, be at least 60 years old, and have a total household income that does not exceed \$1396 for 1 person or \$1888 for 2 people. Currently, 102 seniors are enrolled in the program with 14 individuals on the waiting list.

Since 2019, the Food Bank began to offer 3 holiday meals to households during Easter, Thanksgiving, and the December holiday season and added a 4th of July Box in 2023. We make every effort possible to fulfil the holiday meal wishes of our eligible families by providing vouchers to cover each family with at least one holiday meal as long as our supplies will meet demand. In 2023, we provided 32,500 lbs. of holiday food and feeding and an additional 900+ families and 150 seniors during the holiday season.

62% of our food bank clients are Apache Junction residents, 24,232 individuals comprised of children, families and seniors experiencing food insecurities due to the inflation. Client's requiring our services fluctuated. However, the senior and child population maintained a steady pace of growth. 33% of our food distributed went to children and 27% of distributed food went to seniors. Many of the individuals/families visiting the food bank indicated they are food insecure due to the rising cost of rent, utilities, fuel, and childcare costs. Chronic health conditions and lack of health care have also attributed to the need for food assistance, especially in our senior population.

Feeding America, the nationwide network of 200 food banks, 21 statewide associations and 60,000 partner food pantries and meal programs, today published a new report highlighting its latest Charitable Food Participation Estimate measuring the number of people who received help from the charitable food sector, of which the Feeding America network comprises a large portion. The report finds that more than 53 million people turned to food banks, food pantries and meal programs for help in 2021, one-third more than prior to the pandemic.

Purchasing Food is what we do with the funding provided to us. It is determined to be a success, that we are able to then continue to feed those facing food insecurities in Apache Junction.

The Feeding America network hosts over 10,000 Backpack Programs across the United States,

Backpack food programs offer families free groceries for weekends and school breaks. Food backpacks include healthy, easy-to-prepare food for kid-friendly meats. Food banks partner with schools, Boys and Girls Clubs, and community centers to distribute backpacks to kids.

Every BackPack Program is unique. Most backpacks include enough food to make a few healthy meals. That way, kids return to school on Monday, ready to learn

Backpacks may include:

Breakfast items like cereal, oatmeal, or granola bars
Easy to prepare meals like mac and cheese, peanut butter and jelly sandwiches, or canned soup or ramen.

Fresh or canned fruit

Snacks

The program is tracked on the Link2Feed System and determined to be successful by student participation. Feeding students is always considered a win. This expanded programing by the Superstition Community Food Bank is greatly needed an appreciated by the Apache Junction Unified School District.

Problem Statement

What is the nature and extent of the problem to which you are trying to address?

We are asking for \$50,000 to help purchase food, holiday food and items to help meet the growing need of food insecure individuals in our community.

We are also requesting \$25,000 to purchase food for the Student "Backpack" Food Program we are operating with cooperation from the Apache Junction Unified School Program, this program offers food to students facing food insecurities over the weekends or on breaks from school.

To whom is this happening?

In 2023, we distributed over 2 million pounds of food through our warehouse, (the equivalent over 1.5M meals) However due to the inflation we saw fluctuating client service needs. The trend in services to our senior (10,302 seniors for the year) and children (11,939 children) population continue to grow the fastest. The clientele needing our services are from "working-poor" families who were barely meeting their financial needs. We continue to serve qualified families, which are those with income less than 185% of the federal poverty level as defined by DES.

Why is this happening? What are the reasons or causes for the problem?

Due to inflation; the rise in cost of food, medical, transportation and shelter continues to cripple the working class and those on fixed incomes. Families and individuals have found the need for assistance because they can no longer afford the basic life necessities. According to Moody's Analytics (statistics) a typical US household spends \$445 more a month to buy the same items they did a year ago. Arizona continues to lead the nation with the highest inflation rate.

SCFB continues to move food in and out of the warehouse to help feed the hungry in our
community. In 2023, we served 3,211 new clients. Many of our clients have indicated
they have been most impacted by inflation and have had food insecurity since the Covid
19 pandemic.

What will happen if the problem is not addressed?

If the issue of inflation and rise in costs is not addressed soon, the need for assistance will continue to increase and the Superstition Community Food Bank will need to impose a reduction of food distributed per household or individual.

What are the gaps between what exists and the solution?

During the Covid 19 pandemic, the Federal Government realized that food banks would see a substantial increase in clientele, therefor providing grants to aid in purchasing and distributing food. In 2022, those funds were no longer available. The Superstition Community Food Bank has also received funds from the Arizona Food Bank Network, these funds are not available as well. In addition, our "Rescue Food" grocery store partners have reduced their purchasing, therefor reducing the amount of food that would normally come to us. With all this said, we have continued to see a rise in clientele seeking assistance.

The solution for the food bank to reduce the gap is to request money from the city & counties, along with donations from the community, organizations and private donors and businesses to assist us in purchasing food.

We are also requesting \$25,000 to purchase food for the Student "Backpack" Food Program we are operating with cooperation from the Apache Junction Unified School Program, this program offers food to students facing food insecurities over the weekends or on breaks from school.

Is this a best practice or has it been proven successful in other places?

Feeding America, United Food Bank and the Arizona Food Bank Network has had proven success utilizing the same methodology we are using towards feeding the hungry.

Is this a new or continuing project?

Our community continues to have individuals and families suffering with food insecurity and homelessness. The concern is heightened due to the ongoing increase in inflation affecting the rise in cost of food, medical, transportation and shelter. The SCFB plans to educate our clientele that we are a food supplemental program to aid (helping to fill the gap in their pantries) not provide 100% of their food needs.

Why is this a need to be addressed?

Many in our community experience food insecurity every year, meaning they lack access to adequate, nutritious foods. SCFB has witnessed this number grow for certain populations as more individuals and families experienced job loss or reduced incomes because of inflation's economic impacts. COVID-19 disrupted the U.S. food supply chain, which contributed to an already existing national hunger concern and huge rise in general cost of living. Cost in Arizona continue to be the highest in the nation and have not subsided since the Covid pandemic.
