2. 25-642 Conduct a public hearing on the feasibility report for a proposed project to be financed by the issuance of the Superstition Vistas Community Facilities District No. 2 Assessment Area No. 3 Special Assessment Bonds.

Zach Sakas, Esq of Greenberg Traurig, outside counsel for the Superstition Vistas Community Facilities District No. 2 presented to the Board the proposed project for Assessment Area 3. He explained that it will cover 575 lots over approximately 63 acres on Warner Ave and the

homeowners will have the option to prepay this amount. It will be a new project for consideration with a total cost of \$2.4 million invested. The assessment amount is \$3,500.00 per lot which is a Not To Exceed amount of \$2,012,500.00 for the bond.

Mr. Sakas explained that Resolution No. SVCFD2 2026-001 approves the bond amount, the feasibility report, and the prior giving of notice for this meeting. Resolution No. SVCFD2 2026-002 approves the assessment diagram that has been prepared by the District Engineer.

The Board had no concerns.

Chair Wilson opened the Public Hearing. Receiving no comments, he closed the Public Hearing.
