A RESOLUTION OF THE BOARD OF DIRECTORS OF THE WATER UTILITIES COMMUNITY FACILITIES DISTRICT (CITY OF APACHE JUNCTION, ARIZONA), DECLARING AS A PUBLIC RECORD AND ADOPTING A CERTAIN DOCUMENT FILED WITH THE DISTRICT CLERK ENTITLED "APACHE JUNCTION WATER UTILITIES COMMUNITY FACILITIES DISTRICT CLASSIFICATION AND COMPENSATION PLAN FOR FISCAL YEAR 2025-2026"; ESTABLISHING AN EFFECTIVE DATE; AND DECLARING AN EMERGENCY.
