The Food Bank will be celebrating 40 years of service on July 8, 2023. They will be serving cake and punch at the food bank located at 575 N. Idaho Road, Suite 701, Apache Junction. The time has not been set as of yet.

Commissioner Brennan shared that Northern Arizona University (NAU) is offering two free education options:

Native American undergraduates can attend NAU tuition free for the fall semester 2023, and

also the incoming freshmen or transfer students, which are classified as "dependent students", determined by FAFSA, can attend the fall 2023 or spring 2024 semester. In addition, veterans are qualified for subsidized tuition through the Pat Tillman Foundation, which many times covers full tuition for an entire degree.
