# FIRST AMENDMENT TO CITY OF APACHE JUNCTION AGREEMENT FOR PROSPECTOR PARK DRAINAGE IMPROVEMENTS

THIS AMENDMENT is made and entered into this 15<sup>th</sup> day of July, 2025, ("the Execution Date") by and between the CITY OF APACHE JUNCTION, ARIZONA, an Arizona municipal corporation ("City"), and PRIMARY CONSTRUCTION INC, an Arizona corporation ("Contractor"), sometimes collectively referred to as the "Parties" or individually as the "Party".

## **RECITALS**

- A. On January 30th, 2025 the Parties entered into an Agreement for Prospector Park Drainage Improvements (the "Agreement") under which City hired Contractor to perform the work in accordance with the terms and conditions set forth in the Agreement.
- B. Due to required engineering/architectural changes, and material delays, the Contractor will need additional time within the schedule to complete the project.

### **AGREEMENT**

NOW, THEREFORE, in consideration of mutual promises contained herein and other good and valuable consideration, the receipt and adequacy of which is hereby acknowledged, the Parties agree to amend the Agreement as follows:

A. Section 4 – CONTRACT TERM: The Term of this agreement shall be performed from February 19, 2025 through October 31, 2025 and shall follow the Construction Schedule target dates as outlined in Exhibit A

Except as expressly amended herein, all other terms and provisions of the Agreement shall remain in full force and effect until the Agreement is terminated.
