Anderson and Lindsay Schube of Gammage and Burnham PLC, to amend the conditions of their Heavy Industrial by Planned Development with a Special Use Permit for a Municipal Solid Waste Landfill (B-5/PD) zoned, 129-acre property at 4050 S. The work would be through Pinal County cooperative contract EC11-009 for \$527,280.59 with a ten percent contingency of \$52,728.00 for a total not to exceed amount of \$580,008.59.

5.	<u>16-139</u>	Presentation and discussion on award of contract to DBA Construction for the reconstruction and repaving of Southern Avenue from Apache Drive to Winchester Road. This work is in partial fulfillment of Fiscal Year's 2015-2016 Street Maintenance Plan and funded through the streets .2% sales tax. The work would be through the cooperative Peoria Job Order Contract #ACON43011C for \$783,469.05 with a ten percent contingency of \$78,346.00 for a total not to exceed amount of \$861,815.05.
6.	<u>16-118</u>	Discussion on appointment to Public Safety Personnel Retirement Board.
