All such remarks shall be addressed to the commission as a whole and not to any member thereof. The chairperson is authorized to ask a speaker to stop speaking and leave the podium or to adjourn the meeting if anyone becomes disorderly, uncivil, makes personal attacks or continues to speak about items that are not within the jurisdiction of the city after being warned such issues are beyond the jurisdiction of the city to act. The commission may not answer questions of the speaker, discuss the matter with one another, but may, at the conclusion: 1) respond to criticism by a speaker; 2) ask the city staff to review a matter; 3) ask staff to place the matter on a future agenda. Each speaker must approach the podium, speak into the microphone, and provide their name and address. There is a three (3) minute time limit per speaker.

> 16-606 Presentation, discussion, consideration and action on proposed Conditional Use Permit case CUP-3-16, a request by Tricon/COB Wickiup LP, represented by Mark and Melissa Hammons of H2 Realty, for approval of a free-standing monument sign to be taller than currently allowed by city code at Newhaven Estates, formerly Wickiup Trailer Park, located at 2015 E. Old West Highway zoned Recreational Vehicle Park (RVP). The request proposes to replace a grandfathered twenty-five-foot- tall sign with an eleven-foot-four-inch-tall sign, the current maximum height allowed is eight feet.
