# D. CONSENT AGENDA

The council may, at this time, take single action on any or all items listed as consent agenda items. These may include, but are not limited to, acceptance of agenda, acceptance of minutes, appointments, acceptance of resignations and adoption of certain resolutions and other items which do not require a public hearing. The consent agenda is a timesaving device of which the mayor and city council is to receive documentation on these items from the city manager for their review prior to the meeting. Any member of the council may remove any item from the consent agenda for discussion and cause a separate vote on the matter later in the agenda.

- **2.** <u>18-463</u> Consideration of approval of minutes of regular meeting of October 16, 2018.
- 3. <u>18-475</u> Consideration of approval of the proposed professional services agreement with TischlerBise, for the preparation of the five (5) year update of the Development Fee Study; Land Use Assumptions, Infrastructure Improvements Plan, and Development Fees as well as an update to Volume II, Chapter 7 Development Fee Ordinance in an amount not to exceed \$68,600.00.
- 4. <u>18-470</u> Consideration of rejection of bid responses for the Winchester Road Sidewalk Improvements Project from Southern Avenue to 16th Avenue. Staff recommends city council reject all submitted bids since they all exceed budgeted funds for the project.
- 5. <u>18-479</u> Consideration of approval of award of contract to Sunland Asphalt for the reconstruction of Idaho Road from Lost Dutchman Boulevard to McKellips Road. The work would be through the Government Procurement Alliance cooperative contract No.17-16P-05 in the amount of \$515,378.27, plus a 10% contingency for unforeseen change orders in the amount of \$51,537.82 and for a total not to exceed \$566,916.09.

The council shall consider any business not yet considered. No member of the public shall be permitted to speak on these items unless invited to do so by the mayor after first submitting a written request-to-speak form with the city clerk.

## M. CALL TO PUBLIC

At this time the public has the privilege to address the council with requests, communications, comments or suggestions relating to city business that are not listed on the agenda. All speakers must have already submitted a written "Request to Speak" form to the city clerk no later than the conclusion of the city manager's report portion of the agenda. If there is a group speaking on the same item, they should select a spokesperson. All such remarks shall be addressed to the council as a whole and not to any member thereof. The mayor is authorized to ask a speaker to stop speaking and leave the podium or to adjourn the meeting if anyone becomes disorderly, uncivil, makes personal attacks or continues to speak about items that are not within the jurisdiction of the city after being warned such issues are beyond the jurisdiction of the city to act. The council may not answer questions of the speaker, discuss the matter with one another, but may, at the conclusion: 1) respond to criticism by a speaker; 2) ask the city manager to review a matter; 3) ask the city manager to place the matter on a future agenda. Each speaker must approach the podium, speak into the microphone, provide their name and address. There is a three (3) minute time limit per speaker.
