Director Larry Kirch gave a presentation for discussion with possible direction to staff from commission regarding amendments to the Apache Junction City Code, Volume II, Chapter 2, Subdivision Regulations necessitated by amendments to Volume II, Chapter 10, Engineering Design Guidelines and Policies by the City Engineer. Director Kirch advised commission that City Engineer Emile Schmid is working on updating Chapter 10. He said staff is proposing merging the provision of Article 10-8 Subdivision Plats, with Chapter 2, Subdivision Regulations, Articles 2-1 through 2-7 and drafting amendments for further consideration by the Planning and Zoning Commission.

Director Kirch said staff would also take a closer look to see if there are any "housekeeping" items that need attention at the same time in the subdivision regulations. He said staff was looking for direction from the commission to merge the changes from Article 10-8 Subdivision Plats into Chapter 2 Subdivision Regulations.

Commissioner Hill moved to direct staff to proceed with merging of provisions of Articles 10-8 of Volume II into Chapter 2 Volume II Subdivision Regulations and drafting any necessary amendments. Commissioner Buzzin seconded the motion. The motion passed with 6-0 vote.

Director Larry Kirch gave a presentation for discussion and possible direction to staff from commission regarding amendments to the Apache Junction City Code, Volume II, Chapter 8, Communications, Article 8-1 Wireless Communication Facilities necessitated by rule changes by the Federal Communications Commission (FCC) and possible conflicting language in Volume II, Chapter 1, Zoning Code.
