Customers who have had deposits refunded may be required to re-post a deposit if the water service has been turned off for non-payment two or more times in any consecutive twelve-month period. Any hardships caused by the re-posting of the deposit may be appealed to the District Manager.

Services metered by 2 inch and larger meters will have deposits returned after 15 consecutive on time payments, upon providing the District with a surety bond equal to 2 months average billing.

No interest will accrue or be paid on customer deposits.
