City Manager Bryant Powell

briefed the council on the item.

Assistant City Manager Matt Busby stated the tentative budget, once it is adopted by the council, requires certain public notifications that have to take place before the final budget comes forward. They cannot increase the budget after tentative budget adoption but they can decrease it if something comes up that they want to take out. That is how it is laid out in state law.

City Manager Bryant Powell stated the amount they wanted for investment in code compliance, to be changed from when they had their last meeting, was an expenditure increase of about \$36,205. It is now in the budget.

Mayor Insalaco opened the public hearing on the item. There being no one wishing to speak, he closed the public hearing and reopened the item to council discussion.

City Manager Bryant Powell asked where the budget is located online so that people can go to it.
