2: Westerly fence along the hwy 88 is not a parking area. (NO PARKING) Signs will be posted before the events.

4: 6 porta johns will be available by the event area. 2 restrooms are available inside the Hitching Post and one more restroom will be available at the Dash In.

When Pony Express came 35 rooms were reserved between Motel 6 and Best Western. These kind of events are good for our business and good for the city.
