

# **HITCHING POST EVENT** **CENTER APPLICATION**

## **ENTERANCE & EXITS**

**1- DAY OF THE EVENTS HITCHING POST WILL BE CLOSED TO THE PUBLIC AND WILL REOPEN AFTER THE EVENTS.**

**2- WESTERLY FENCE ALONG THE HWY 88 IS NOT A PARKING AREA. (NO PARKING) SIGNS ARE ALREADY POSTED.**

**3- EVENT AREA WILL BE CLOSED. NO PARKING WILL BE ALLOWED AND (NO ALCOHOL BEYOND THIS POINT) SIGNS WILL BE POSTED BEFORE THE EVENTS.**

**4- WE WILL OPEN THE EVENT AREA GATE AFTER THE EVENTS FOR PUBLIC PARKING.**

## **EXIT PLAN**

**2 POLICE OFFICERS WILL BE DIRECTING TRAFFIC. LIGHT TOWER WILL BE PROVIDED BY THE POLICE DEPARTMENT.**

# **GATES**

## **GATE "A"**

**THIS GATE IS ALWAYS OPEN TO THE PUBLIC. IT IS OVER THE NORTH EAST SIDE AND TO GET THE GATE YOU HAVE TO GO TO THE LOST DUTCHMAN BLVD. POLICE WILL BE AT THE GATE ON THE DAY OF THE EVENTS. THIS GATE WILL GIVE AXCESS TO THE "B" PARKING AREA, WHERE 82 CARS CAN BE PARKED. SECURITY WILL BE AVAILABLE TO HELP PARK THE VEHICLES INSIDE THE GATES.**

## **GATE "B"**

**THIS GATE WILL BE USED FOR OVERFLOW PARKING (STORAGE) AREA. SECURITY PERSONELL WILL BE AVAILABLE TO HELP PARK IN SUFFIENT MANNER.**

## **GATE "C"**

**THIS GATE WILL REMAIN CLOSED DURING THE EVENTS. WE WILL OPEN THIS GATE AFTER THE EVENTS SO PEOPLE CAN GET TO THEIR CARS.**

## **GATE "D"**

**GATE "D" WILL BE INSTALLED BEFORE THE EVENTS WHICH WILL BE ENTERANCE TO THE PARKING AREA WHERE WE WILL BE HAVING EVENTS. AFTER THE EVENTS WE WILL OPEN IT UP FOR PARKING.**

**3: ‘C” SHOWS THAT WE HAVE 201 SPACES AVAILABLE FOR ANY OVERFLOW PARKING NEEDS.**
