A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF APACHE JUNCTION, PINAL AND MARICOPA COUNTIES, ARIZONA, DECLARING AND ADOPTING THE RESULTS OF THE PRIMARY ELECTION HELD ON AUGUST 30, 2016.

WHEREAS, the City of Apache Junction, Pinal and Maricopa Counties, Arizona, did hold a primary election on the 30th day of August, 2016, for the nomination of a mayor and three councilmembers and Proposition 410, a proposition for the extension of a Local Alternative Expenditure Limitation (home rule option); and

WHEREAS, the election returns have been presented to and have been canvassed by the city council.

NOW, THEREFORE, BE IT RESOLVED by the mayor and council of the City of Apache Junction, Pinal and Maricopa Counties, Arizona, as follows:

SECTION 1. That the total number of ballots cast at said primary election, as shown by the attached reports from Pinal and Maricopa Counties, marked as Exhibit A-1 through A-10, was 4,827.

SECTION 2. That the number of ballots rejected, as shown by the attached reports from Pinal and Maricopa Counties, marked as Exhibit A-1 through A-10, was 21.
