CASE NO. PLN2016-00002
SUPPLEMENT TO THE CITIZEN PARTICIPATION REPORT
SUBMITTED OCTOBER 21, 2016

The purpose of this Supplement to the Citizen Participation Report is to document Apache Junction Landfill Corporation's ("AJLC") ongoing communication and voluntary neighborhood meeting with interested citizens and representatives of the Silver Bar Landfill regarding the Apache Junction Landfill Planned Development Amendment ("Application") request (Case No. PLN2016-00002).

On February 24, 2016, the AJLC submitted its Citizen Participation Report to the City of Apache Junction for the Application. On April 19, 2016, the Apache Junction City Council continued the Application to December 6, 2016. Following the April 19, 2016 hearing, AJLC and its representatives voluntarily conducted additional public participation and outreach to: (1) the potentially interested community within Apache Junction; (2) citizens that signed a petition opposing the Application; and (3) representatives of the Silver Bar landfill located approximately 24 miles southeast of the Apache Junction Landfill.

Additional Citizen Outreach

At the April 19, 2016, City Council meeting, Ms. Diane Burns, who resides nearly 6 miles north of the Apache Junction Landfill in unincorporated Pinal County, submitted 36 petitions opposed to the Application. Following the Council hearing, AJLC attempted to contact everyone that signed a petition and provided their contact information. The purpose of this follow-up was to involve and

facilitate ongoing communication with these interested citizens, and to provide them an opportunity to learn about the Application.

Of the 36 petitions submitted, AJLC successfully established contact with 9 citizens. AJLC responded to questions regarding height, groundwater monitoring, landscaping, property values, and closure date. After speaking with AJLC, none of these 9 citizens expressed ongoing opposition to the Application. AJLC called (and left voicemails when possible) and/or sent emails to 19 citizens. AJLC received no return telephone calls or reply emails from any of these citizens. AJLC was unable to establish contact with 8 citizens because they did not provide their telephone number and/or email address on the petition.

Silver Bar Outreach

AJLC met with Mr. Mike Cowley and Mr. Andy Kunasek, representatives of the Silver Bar landfill, the week of June 13, 2016. (As documented in the Citizen Participation Report dated February 24, 2016, Mr. Kunasek attended AJLC's neighborhood Open House on February 11, 2016.) At this meeting, Mr. Cowley and Mr. Kunasek offered to sell the Silver Bar landfill to AJLC. AJLC subsequently declined this offer during a telephone call on August 2, 2016, and followed up with a confirming e-mail to Mr. Kunasek on August 3, 2016.

Second Neighborhood Meeting

AJLC voluntarily hosted a second Neighborhood Open House on Wednesday, September 28, 2016, from 6:30 pm to 7:30 pm at the Apache Junction Parks & Recreation Multi-Generational Center. At the Open House, representatives of AJLC, along with Mr. Larry Kirch, City of Apache Junction Development Services Director, and Mr. Rudy Esquivias, City of Apache Junction Senior Planner/Zoning Administrator, were available to describe and discuss the Application.

AJLC maintained a sign-in sheet and provided comment cards to interested attendees. Twenty-six individuals signed-in and four (4) completed comment

cards were submitted. The sign-in sheets and completed comment cards are attached at Tab A. It should be noted that not all attendees chose to sign-in.

Representatives of AJLC met with approximately ten (10) interested citizens that arrived at 6:00 pm, thirty (30) minutes prior to the noticed start time of the Neighborhood Open House. Approximately forty (40) additional interested citizens attended the Neighborhood Open House between 6:30 pm and 7:30 pm. Representatives of AJLC provided an overview of the proposal, and responded to questions and comments regarding the existing and proposed height, environmental regulations, day-to-day operations, and closure date of the Apache Junction Landfill. Nearly all attendees were unaware that the current Apache Junction Landfill does not have a set closure date.

Scope of Notice for Second Neighborhood Meeting

AJLC provided notice of its voluntary Second Neighborhood Open House to the same property owners and interested parties included in the Required Neighborhood Open House meeting held on February 11, 2016. This list included all properties within one-quarter mile of Tomahawk Road (on the east and west) between the subject property and US 60, the Arizona State Land Department, the City's Development Services Director, Mr. Kirch, and the City's Senior Planner/Zoning Administrator, Mr. Esquivias. As was the case with the Required Open House, this scope of notice is far beyond the City's requirements for notice. Additionally, AJLC provided notice to all property owners who have expressed any interest in the case through the City hearing process, including all the property owners who submitted a petition in opposition of the request at the April 19 City Council hearing and anyone who spoke at any of the public hearings conducted by the City. Over two hundred and fifty (250) property owners and interested parties were notified. The notification letter and mailing addresses are attached at Tab B.

Other Inquiries

Gammage and Burnham received a telephone call on September 23, 2016 from a property owner who received notification for the September 28, 2016 Neighborhood Meeting. He and his wife live out of the Country and own the home as an investment property. They have not been down here to see the property since 2008. After the applicant described the application the property owner said he was neutral on the proposal.

The Applicant has received no other telephone calls, emails or other inquiries as of October 21, 2016.
