On May 16, 2018, 88 Trails Corp. ("88 Trails") purchased the real property and improvements (convenience store and fuel station) at 1571 W. Apache Trail in Apache Junction under a court-approved sale in the previous owner's receivership case. The store was continuously licensed with a series 10 liquor license from July 26, 1990 until it closed in October, 2017. The most recent application and interim permit were withdrawn on October 17, 2017. Because an interim permit was in place, the previous owner did not renew the license prior to its expiration on August 31, 2018.

Pursuant to ARS 4-209(A), we respectfully request you authorize 88 Trails to renew the expired license, and approve issuance of an interim permit in conjunction with 88 Trails' application for a new series 10 license.


