The commission and staff discussed that B2 means business in the downtown area and PD means planned development overlay which is usually intended for site and building flexibility.

The commission and staff discussed that there are still several parcels in the area with older zoning designations and there is no plan at this time for staff to update them.

The commission and staff discussed that the property owner negotiated with city staff that the billboard will be removed with the change in the zoning designation.

Commissioner Heck moved, seconded by Commissioner Ooley, that the Planning and Zoning Commission direct staff to initiate a rezoning of Prickly Pear RV Park, located at 1630 W. Apache Trail from Recreational Vehicle Park to Old West Commercial by Planned Development which is B2/PD. Approved in a vote of 6 in favor and 0 opposed. (Yes: McGraw, Kridler, Ooley, Nesser, Howard, Heck. No: none.)
