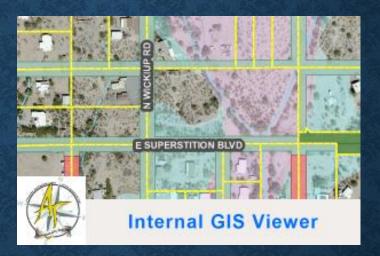

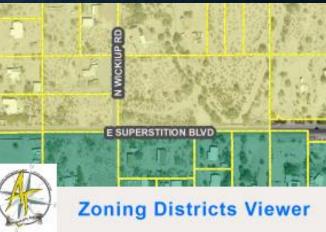

# INCREMENTAL ECONOMIC GROWTH

- National GDP estimates growth of 2.5% (down from 2.9% in 2018)
- State estimates revenue growth of 7.7%
- City's budget committee estimates revenue growth at 7%
- Net new revenue equals approximately \$1.9 Million

- 1 new part time position (Library Page) this will allow the library to stay open later on Mondays and Wednesdays
- Continued focus on Fleet

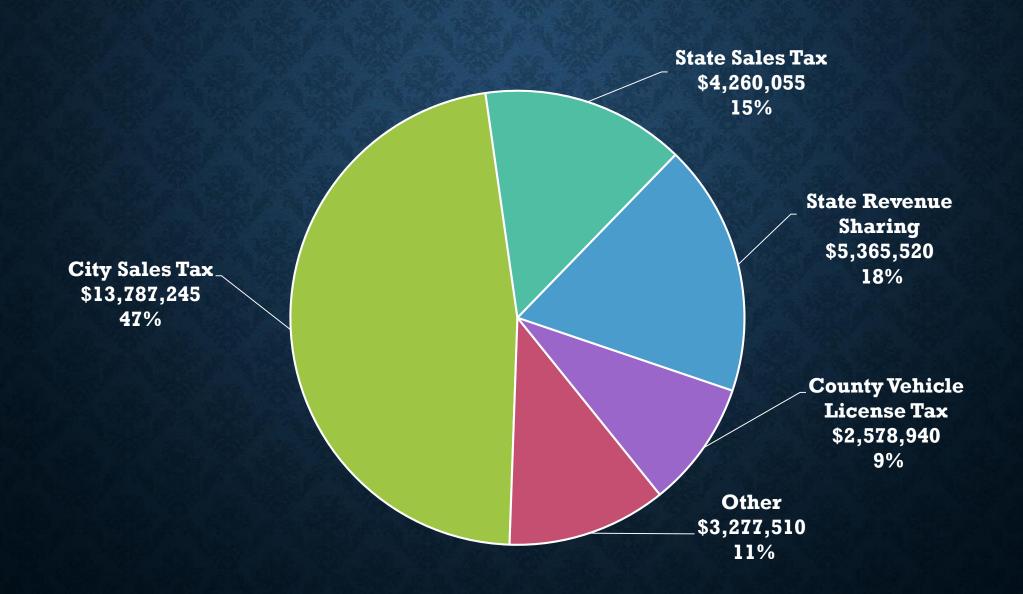

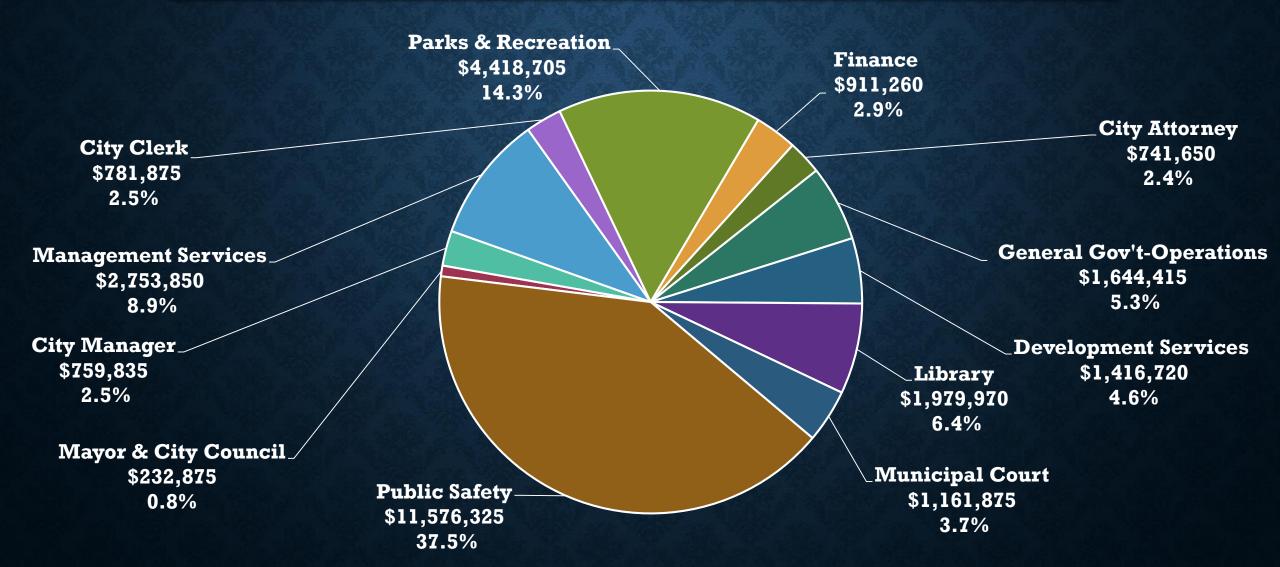

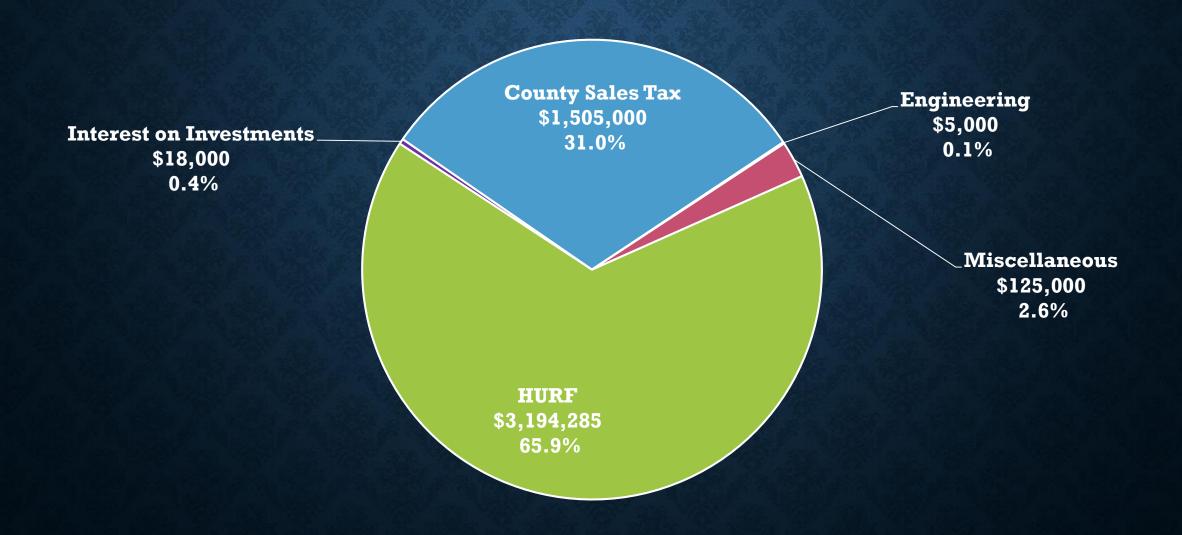
## **GENERAL FUND REVENUES**
