Board Details

The primary duty of the Board is to hear and decide appeals made by individuals regarding construction codes and decisions made by the Building and Safety Manager. To provide for reasonable interpretations of the provisions of the Technical Codes to determine the suitability of alternate materials and methods of construction; and to recommend changes of the various building and fire codes to the Building and Safety Manager. The Board handles complaints of discrimination by property owners as well. There are five members appointed by the City Council to three-year terms. The members need not be residents of the City. Board members meet only on an asneeded basis.
