FIRST AMENDMENT TO AGREEMENT FOR LANDSCAPE MAINTENANCE SERVICES BETWEEN CITY OF APACHE JUNCTION AND BRIGHTVIEW LANDSCAPE SERVICES, INC.

THIS AMENDMENT is made and entered into this 1914 day of 20 19, ("the Execution Date") by and between the CITY OF APACHE JUNCTION, ARIZONA, an Arizona municipal corporation ("City"), and BRIGHTVIEW LANDSCAPE SERVICES, INC., an Arizona corporation ("Contractor"), sometimes collectively referred to as the "Parties" or individually as the "Party".

RECITALS

- A. On June 5, 2018, the Parties entered into an Agreement for landscape maintenance (the "Agreement") for various city-owned areas.
- B. The Parties acknowledge that Arizona's Proposition 206 minimum wage increase has resulted in higher operating expenses for Contractor.
- C. The Apache Trail median project with new trees and plants along Royal Palm are an additional maintenance responsibility not contemplated under the Agreement.
- D. Areas in the scope of work have also expanded to include routine weekly maintenance.
- E. Based on the above circumstances, the Parties acknowledge a ten percent (10%) increase to the original contract price is reasonable.

AGREEMENT

NOW, THEREFORE, in consideration of mutual promises contained herein and other good and valuable consideration, the receipt and adequacy of which is hereby acknowledged, the Parties agree to amend the June 5, 2018 Agreement as follows:

- A. Section 2. <u>PRICES</u>: Prices shall be governed under Exhibit A for the performance of the Work under the contract documents.
- B. Section 3. <u>CONTRACT TERM</u>: The Term of this Contract shall be performed from November 15, 2019 through November 15, 2020. Additional renewals are addressed in § 21 of this Agreement.
- C. Except as expressly amended herein, all other terms and provisions of the Agreement executed by the Parties shall remain in full force and effect until this Amendment is terminated.
