Presentation, discussion and consideration for approval of a retro-active construction contract with Southwest Waterworks Contractors PM LLC for pump replacement at Well #5 located at 2401 West 16th Avenue in the amount of \$160,644.00 plus 10% for contingencies in the amount of \$16,064.40, for a total not to exceed \$176,708.40.

District Director Mike Loggins presented the results of the inspection at Well #5 located at 2401 West 16th Avenue. Well #5 pump, column pipe, tube and shaft have been pulled. The results found were a split in the pipe column had occurred; column pipe, tube and shaft were severely pitted and require replacement. Staff recommends brush and bail of well, perform a well treatment to open perforations; video well to verify perforations are open and replace column pipe, tube and shaft. Staff is recommending awarding the contract to Southwest Waterworks Contractors PM LLC.

Board Member Barker made a motion that retro-active approval of a construction contract be given for the pump replacement at Well #5 between Apache Junction Water Utilities Community Facilities District and Southwest Waterworks Contactors PM LLC in the amount of \$160,144.00 plus 10% for contingencies in the amount of \$16,064.40, for a total not to exceed \$176,708.40 be approved.
