District Director Mike Loggins presented an update on the total Trihalomethanes for the 4th quarter 2019. Running Annual Average has dropped to normal levels since the installation of the Chlorine Dioxide Generator. District Director Mike Loggins presented information about the Water District's Backflow Prevention Program and gave examples about the importance of installing Backflow Preventers within the Apache Junction Water District's service area in order to protect the water system.
