## Federal CARES Act

Purpose: To assist local governments to cover costs directly and indirectly incurred due to impacts of COVID-19 pandemic.

## AZ Cares Fund

## Fund information and requirements:

\& Local jurisdictions may receive a direct allocation from the AZCares Fund for public safety employee (police, fire, EMS, 911) salary and benefit costs incurred between March 1, 2020 and December 30, 2020.

* Each jurisdiction has a specific dollar allocation based on population.
* Apache Junction's - $\$ 4.8$ million
\& The local jurisdiction must submit actual and estimated costs to state grant system to receive funds.


## AZ Cares Fund

## Fund information and requirements:

Public safety payroll costs are the qualifying mechanism, required by the State, to get funds reimbursed to the local jurisdictions.
"Once the local jurisdiction has reimbursed the previously incurred public health and public safety cost, they are free to deploy the local resources to any purpose decided upon by that jurisdiction."
