proposed city initiated corrective rezoning of 210 N. Ironwood Dr., located near the northwest corner of Ironwood Dr. and Apache Trail, from a split zoning of Recreational Vehicle Park (RVP) and General Commercial (B-1) to General Commercial (B-1) to allow the entire property to be developed under commercial standards as intended by the original zoning designation.
