City Clerk Jennifer Pena presented that many of the local small non profits have not applied because they cannot afford to do a CPA audit. In Ms. Pena's review, the term audit is so broad in the city code that it allows the commission and staff the ability to look and determine what is sufficient financial documentation so that we know they are doing proper bookkeeping and that an official CPA audit will no longer be required. The tax auditors in the city clerk's office are available to review the financial documentation as well, if needed.

Commissioner Mitchell expressed his approval of this change in that it will now allow more small non profits the ability to apply for funding.

Commissioner Erickson thanked Ms. Pena for her research and is looking forward to more non profits being able to apply and not have to incur the significant expense of a CPA audit.
