A RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF APACHE JUNCTION, ARIZONA, DECLARING AS A PUBLIC RECORD THAT CERTAIN DOCUMENT FILED WITH THE CITY CLERK ENTITLED "2021 AMENDMENTS TO THE APACHE JUNCTION CITY CODE, VOLUME II, LAND DEVELOPMENT CODE, CHAPTER 10: ENGINEERING STANDARDS"; REPEALING ANY CONFLICTING PROVISIONS; AND PROVIDING FOR SEVERABILITY.

WHEREAS, A.R.S. § 9-802 permits municipalities to enact the provisions of a code of public record theretofore in existence without setting forth such provisions in full text as long as the adopting ordinance is published in full text and at least three paper copies, or one paper copy and one electronic copy of the code or public record, are filed and made available for public inspection in the office of the city clerk and the electronic copy is accessible on the city's website and is made available for public inspection; and

WHEREAS, pursuant to A.R.S. \S 9-801(1) and 9-802, such codes can include regulatory provisions relating to engineering standards; and

WHEREAS, city staff has identified such provisions herein, and it is the intent of the city to declare such documents and compilations as public records, on file in the office of the city clerk and electronically accessible through the city's website (www.apachejunctionaz.gov).

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF APACHE JUNCTION, ARIZONA, AS FOLLOWS:

SECTION I: DECLARATION OF PUBLIC RECORD

That certain document entitled "2021 Amendments to the Apache Junction City Code, Vol. II, Land Development Code, Chapter 10: Engineering Standards", is hereby declared to be a public record, at least three paper copies, or one paper copy and one electronic copy of which are filed and made available for public inspection in the office of the city clerk of the City of Apache Junction, Arizona, and accessible through the city's website (www.apachejunctionaz.gov) is hereby declared to be a public record, shall be made available for public use and inspection; and said copies are ordered to remain on file with the city clerk.

SECTION II: REPEALING ANY CONFLICTING PROVISIONS

All resolutions and parts of resolutions in conflict with the provisions of this resolution or any part of the codes adopted herein by reference are hereby repealed.

SECTION III: PROVIDING FOR SEVERABILITY

If any section, subsection, sentence, phrase, clause or portion of this resolution or any part of the codes or regulations adopted herein by reference is for any reason held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions thereof.
