Presentation and discussion and possible recommendation on the Planned Development Major Amendment to change the last five buildings or twenty townhomes from single-story basement homes to two-story homes for the Superstition Commons (formerly known as the Haystacks), totaling approximately +/-4.9 acres, located at 854 South San Marcos Drive on the Southwest corner of South San Marcos Drive and West Broadway Avenue.

Planning Intern Jesse Regnier gave a presentation for discussion and possible recommendation on the Planned Development Major Amendment to change the last five buildings or twenty townhomes from single-story basement homes to two-story homes for the Superstition Commons (formerly known as the Haystacks), totaling approximately +/-4.9 acres, located at 854 South San Marcos Drive on the Southwest corner of South San Marcos Drive and West Broadway Avenue.

Intern Regnier reviewed the recommended conditions of approval for the amendment approval with the commission. He addressed their questions regarding whether the project was on hold, the current zoning regarding height, eliminating the basements, architectural details, and locations of buildings.

Senior Planner Rudy Esquivias elaborated on the commission's questions regarding height, architectural details, and building locations.

Charles Duck, representing Superstition Commons, addressed the commission. He answered the commission's questions regarding floor plans, concern regarding possibility of rentals, marketability of two-story versus basement homes, heights of buildings.

Chairperson Nesser opened the Public Hearing.

Susan Kreun, representing Equity Lifestyle Properties, owners of Golden Sun RV Resort; Reggie Kollinger, 820 W. 10th Avenue, Apache Junction; Robert Lewis, 896 W. 10th Avenue, Apache Junction; Christopher Rogalski, 893 W. 10th Avenue, Apache Junction; David Ameal, 860 W. 10th Avenue, Apache Junction; Drew Griner, 968 W. 10th Avenue, Apache Junction; addressed the commission regarding safety, stormwater runoff, carports, comparables, views, whether developer followed zoning rules, privacy, possibility of townhomes becoming rentals, landscaping and 73 police calls in 3 years.

Chairperson Nesser asked Susan Kreun to see Rudy Esquivias in regards to her concerns about drainage and wall issues; and commented on some of the concerns of some of the other speakers.

Chair Nesser closed the Public Hearing.

Charles Duck addressed the commission to clarify some of the comments made by the speakers.

Chair Nesser re-opened the Public Hearing.

Jeff Stachar, 1860 E. Broadway, Apache Junction; Reggie Kollinger, 820 W. 10th Avenue, Apache Junction; addressed the commission regarding allegations of decisions made to financially benefit the developer, and the pool.

Chair Nesser asked Senior Planner Rudy Esquivias to clarify some items to the commission. Senior Planner Esquivias and Director Kirch went over some questions with the commission.

Chair Nesser closed the Public Hearing.

The commission and staff discussed the issues expressed during the public hearing.
