#### 8. New Business

<u>19-466</u> Presentation, discussion and direction to staff on a proposed request for a city initiated rezoning of the area bounded by Ironwood Drive, Gold Drive, Roundup Street, and Greasewood Street from RS-20M (Medium Density Single-Family Detached Residential) to RS-10M (Medium Density Single-Family Detached Residential).

Planning Intern Leftwich gave a presentation on proposed rezoning of the area bounded by Ironwood Drive, Gold Drive, Roundup Street and Greasewood Street.

The commission and staff discussed that the rezoning is requested to correct the inaccurate rezoning which was done in 2014 when the city passed the new zoning ordinance; that North Silver Drive is an alignment, not an official street but contains utility easements, that exists south of Apache Trail and only exists in a few spots north of Apache Trail; that part of the rezoning will include asking the property owner for a 33' dedication which is equal to the FPE; that staff is looking for a direction to staff to proceed and meet with the neighbors at which time the commission can decide what they'd like to do; that since this is a city initiated rezoning the city had to pay for a surveyor to come and survey the lots and provide a legal descriptions of the lots; that more outreach is needed to determine if this will move forward; that staff is seeking direction from the commission to open the discussion with the property owners; and that there are encroachments on FPEs that were done before the city became incorporated.

Chair Nesser called for a motion.

Vice Chair Heck motioned and seconded by Commissioner McGraw that the Planning and Zoning Commission direct staff to initiate a rezoning of the area bounded by Ironwood Drive, Gold Drive, Round Up Street and Greasewood Street from RS-20M, Medium Single Family Detached Residential, to RS-10M, Medium Single Family Detached Residential. I further move that staff take all actions necessary to meet the legal requirements set forth in state law regarding notification of this pending action. Approved in a vote of 7 in favor and 0 opposed. (Yes: McGraw, Nesser, Ooley, Hantzsche, Heck, Howard, Kridler. No: none.)
