Presentation, discussion, and consideration for Resolution No. 20-23, a resolution of the Mayor and City Council of the City of Apache Junction, Arizona, approving a small business assistance grant program in the City of Apache Junction and declaring an emergency for grant funding recently made available through the Coronavirus Aid, Relief and Economic Security ("CARES") Act (signed into law by President Trump on March 27, 2020 under Pub. L. 116-136).

Councilmember Barker moved, seconded by Councilmember Evans that Resolution No. 20-23, a resolution of the Mayor and City Council of the City of Apache Junction, approving the implementation of a small business assistance grant program in the City of Apache Junction and declaring an emergency for grant funding recently made available through the Coronavirus Aid, Relief and Economic Security ("CARES") Act for a one-time reimbursement for COVID-19 related impacts be approved with the following amendments:

- 1. allow nonprofits to apply for the grant for a total of \$200,000.00 with a cap of \$10,000.00 for each nonprofit
- 2. add nonprofits to the title of the application
- 3. add a whereas clause that local nonprofits are an integral part of the community and provide services for the community
- 4. create a separate application for nonprofits requiring the same criteria as a small business
- 5. the remaining amount to be spent on public safety

Mayor Serdy explained that council received a letter from Apache Junction Police Officers Association (AJPOA) and it was brought to his attention that the CARES Act money is in fact meant to also go towards public safety wages and he intends to make sure that happens.

Assistant City Manager Matt Busby reviewed the presentation that was given at the July 7th council meeting.

Development Services Director Janine Solley explained staff's recommendation for the Apache Junction Small Business Assistance Grant Program; including the application process, criteria and next steps. City staff is recommending to spend 25% of the \$4.8 million to assist small businesses with reimbursement of rent, utilities and PPE with a maximum reimbursement of \$10,000.00 per business. Ms. Solley clarified that the grant program will run from July 21st to August 25th and is on a first come first serve basis.

Mayor Serdy asked what happens if the city doesn't receive many applications and all 25% is not used for businesses and can it be used for Public Safety?

City Manager Bryant Powell stated that it can and to include that in the motion if that is what council wants.

Councilmember Evans asked if there are any repercussions if a business receives the grant and then goes out of business in a couple months?

Ms. Solley stated that we do not have anything listed if that were to happen but documentation is

required before businesses can be awarded a grant.

Councilmember Evans asked how council felt about allowing nonprofits to apply for the grant.

Vice Mayor Wilson shared that nonprofits have been able to get grants specifically designated for them and that if the city has money left over that is intended for the businesses that we can then allow nonprofits to apply.

City Attorney Joel Stern clarified that the grant program is entitled "Apache Junction Small Business Assistance Grant Program" so the resolution would need to be edited in order to include nonprofits and informed council to include that in their motion if that is what they would like.

Council discussed scenarios on how much should be allocated to nonprofits to apply for.
