City Manager Bryant Powell explained that this is the first of two public hearings to adopt Fiscal Year 2021-2022 city budget.

City Manager Matt Busby presented what is included in this budget including new positions and facility improvement and maintenance projects. Mr. Busby shared general fund and HURF revenues and expenditures and possible financial threats in the future.

Councilmember Biggs asked why the Police Department is our biggest expense. Mr. Busby responded that the Police Department consists of four divisions and houses the most employees.

Vice Mayor Rizzi shared that we are thankful that our community supports our Police Department. She explained that we have a pretty conservative and trim budget.

Mayor Wilson opened the public hearing.

Jeff Struble thanked the city council and staff for their work on the budget. He explained three duties that a government is responsible for and does not think it is the government's purpose to fund health and human service organizations. He read the city's vision and mission statement. It saddens him that the public does not attend the budget meetings and get more involved.

Mayor Wilson closed the public hearing.

Vice Mayor Rizzi commented that she sees things a little differently now and sees where Mr. Struble is coming from.
