Discussion of the following items with Dianne Cripe of Artspace 6, LLC:

- Consulting Services Agreement with Artspace 6: status of scope of work
- Future projects and a new/revised scope of work

Director Kirch handed out a Public Art Consultant Contract Scope of Work - April 2021 to April 2022 and April 2022 to April 2023. Dianne Cripe of Artspace 6, LLC discussed the status of the current scope of work, including Task 1: review ordinances and policies, Task 2: Public Art Commission support and workshop, Task 3: Public Art Project management, Task 4: donations of artwork and Task 5: develop an art collection management system. Ms. Cripe discussed several items pertaining to budget, prioritization, best practices and donation policy, including type of artwork and maintenance, and removal of public art. She stated an excel spreadsheet would be sufficient for the collection management system.

Director Kirch discussed the current and future tasks on the handouts and the scope of work services for the next contract with Artspace 6, LLC, and stated that we will wait until Dutchman Dog Park art is underway and then might amend the ordinances under Task 1. He stated after the dog park artwork is done, we can debrief and discuss what worked and didn't work before beginning the round-a-bout art project. He stated the Dutchman dog park artist contract will be a council resolution. Dianne Cripe discussed the differences between Tasks 5 and 6 and the range for the selected artist for the Dutchman dog park. She stated if you have any questions or ideas to bring to the Development Services Department.

Commissioner Klett mentioned an artistic 3-dimensional crosswalk by the Hitching Post. Director Kirch responded that it was a state highway, and another option might be a city street near another piece of public art. Commissioner Klett mentioned painting of utility boxes and Dianne Cripe responded you have to get an artist that knows graphics and vinyl wraps that might not last in the desert sun, and the steps involved. Director Kirch spoke about a city-wide master public arts plan.
