Commissioner Barker moved that the Planning and Zoning Commission recommend to the Apache Junction City Council the approval of case P-22-10-PZ, a planned development major amendment request by Axiom Care, represented by Andrew Lorentzen of Rose Law Group, PC, to amend the planned development on the property at 150 N. Ocotillo Drive in order to construct a new, three-story treatment facility, located north of the northwest corner of Apache Trail and Ocotillo Drive, subject to the conditions of approval that are listed in the staff report dated April 12, 2022. Commissioner Begeman seconded the motion.

Planner Schattnik gave a presentation on P-22-10-PZ and asked for questions from the commission.

Chair Heck asked if the two existing buildings would remain and be updated. Planner Schattnik responded yes, and that one of the conditions of approval is to update the existing buildings.

Commissioner Cantwell asked about the reason for the 38' building height. Interim Director Esquivias responded and said he would defer to the architectural team for specifics.

Commissioner Gage asked if the site was served by the sewer district. Planner Schattnik responded yes, and Commissioner Barker stated it was in the staff report.

Thomas Galvin from Rose Law Group, on behalf of the applicant, Axiom Care, gave a presentation on the following:

- substance abuse and addiction, and the innovative Therapeutic Community model.

- the facility itself and the 41 parking spaces for the proposed expansion. He stated there was no public input to date.

- the increased ceiling height necessary for Therapeutic Community methods and a benefit for patients.

- criteria for PD request.

The various questions from the commission included visitors, ADA parking, staff parking, number of staff working per shift, lighting for security, secured facility, length of treatment, exterior look of building, 24-hour intake, renovation of the inside.

Christine Stevens of Axiom Care responded to the various questions, including:

- the visitation process.

- parking will be ADA compliant.

- staff parking is 11 spaces, the day shift staff would consist of 2 nurses, 3 techs, 1 admin, 1 cook and 1 housekeeper, and various doctors.

- no issues with lighting, but if it is a concern would be addressed.

- not a locked facility.
- levels of care/discharge plan.
- the detox building has already been renovated, the admissions building will be renovated.

Chair Heck opened the public portion of the hearing.

George Schroeder, 2444 W. Virginia St., stated that he's seen every drug addict in the past 40 years living in the area. He asked about security, gates, preparation for people who might die. He stated he is a big proponent of helping people but feels this is not the right neighborhood for the facility.

Chair Heck closed the public portion of the hearing.

Chair Heck asked for questions from the commission.

Comments from the commission included:

- parking
- security
- ceiling height
- concern about connection to sewer
- a benefit to the community

Chair Heck re-opened the public portion of the hearing.

Thomas Galvin from Rose Law Group responded to the commissions comments, and stated that they will have 24-hour staff onsite for security, and the facility is hooked up to sewer.

Chair Heck closed the public portion of the hearing.

The commission went over the findings of fact and all were in agreement.
